VISA LIBRARY

To use this software, VISA library need to be installed on your PC.

VISA (Virtual Instrument Software Architecture) library is a standard specification for measurement instrument connection software, which was developed by VXIplug&play Sytems Alliance.

A KIKUSUI original KI-VISA is available that supports IVI VISA specifications 5.0. If you want to use this software on Windows 10, download KI-VISA (Ver.5.5 or later) from the Kikusui Electronics Corporation website download page (https://www.kikusui.co.jp/en/download/).

The following other VISA libraries can also be used. Confirm the license terms of each VISA library before installation.

- NI-VISA by National Instruments (Ver.19.0 or later)
- Keysight IO Libraries Suite (Ver.2019 or later) by Keysight Technologies

If NI-VISA or Keysight IO Libraries Suite is already installed on your PC, you do not need to install KI-VISA.

OPERATION MANUAL

POWER SUPPLY CONTROLLER

PIA4850

The PIA4850 is a controller designed to digital control Kikusui's DC power supply unit with a TP-BUS via USB. The Kikusui's DC power supply unit with an analog remote-control function can be controlled using the expansion unit PIA4820.

For details of connection of power supply, PIA4820 and device messages, see the "Connecting & Programming Guide." The "Connecting & Programming Guide" is provided in the accompanying CD-ROM.

When inserting the CD-ROM in drive, the menu program will be started as shown below. Click on the "Connecting & Programming Guide."



The "Connecting & Programming Guide" is in HTML format that can be viewed with a WWW (World Wide Web) browser. The Microsoft Internet Explorer 11 or later browsers is required to view this manual.




Checking the Package Contents

Part Names and Functions



No.	Name	Description
1	TP-BUS connector	Connect the TP-BUS communication cable.
2	Switch	Switch for firmware update. Normally set the switch position to the right side.
3	USB connector	Connect the USB cable.
4	POWER LED	Lights up or blinks by the power line failure or internal errors.
5	TP LED	Lights up during communication in TP-BUS line.
6	Serial number	Serial number of PIA4850.

Connection

Use a standard USB cable to connect the PIA4850 to the PC. Once it is connected, the PIA4850 will be turned on the power. For detail of connection of the PIA4850 to the PC, see the "Connecting & Programming Guide" on the accompanying CD-ROM.

VISA Library

In case of using USB to control the PIA4850, any of the following VISA library is required to be installed at the PC. The newest version can be downloaded from each company's website. Do not install the plural number of VISA library to the PC. It may cause possible malfunction.

- NI-VISA Ver. 3.0 or later by National Instruments.
- Agilent VISA (Agilent IO Libraries) M01.00 or later by Agilent Technologies.
- KI-VISA Ver. 3.0.x or later

■ Installing KI-VISA

KI-VISA is Kikusui's original VISA library that supports VXIplug&play VISA Specifications 3.0. The newest version can be downloaded from Download service of Kikusui website (http://www.kikusui.co.jp/en/download/). KI-VISA is not required if NI-VISA or Agilent VISA is already installed.

Double-click Kivisa_3_0_x.exe, then proceed with the installation according to the instructions on the screen. The value for x varies depending on the revision of the VISA library stored on the CD-ROM.
